

A WP No.5525/2018 is pending before the Hon'ble High Court of Bombay at Nagpur in the matter of Mahesh Sriram Khoragade & others vs. Union of India & others. The main prayer in the petition is to conduct election of board of the society and also direct the society not to take any policy decision and also not appoint any personnel including promotion etc.

~~In this regard it is informed that the term to the existing board has already expired. Therefore, the existing board has no locus standing to take any policy decision including appointment and promotion of employees except to manage affairs of the society.~~

The Registrar of Cooperative Societies, West Bengal as well as the General Manager of South Eastern Railways have been requested to furnish a list of officers for appointment of Returning Officer for holding the election. On receipt of the list, further action could be taken for appointment of Returning Officer to conduct election to the delegates and the board of your society.
